## *1. Limitations:*

*The ratings set forth in the Approved Maintenance Organization Certificate No. 72-09 are the following:*

- AIRFRAME** - Limited to perform installations, maintenance, repair and modifications of Radio, Instruments, Electrical and Accessory Systems related to airframe as listed in the CAAP approved Capability List, as revised
- AVIONICS** - Limited to perform test, repair and overhaul of related avionics as listed in the CAAP approved Capability List, as revised.
- INSTRUMENTS** - Limited to perform test, repair, and overhaul of related aircraft instrument as listed in the CAAP approved Capability List, as revised.
- ACCESSORIES** - Limited to perform test, repair and overhaul of aircraft accessories as listed in the CAAP approved Capability List, as revised.

All work shall be accomplished in accordance with current manufacturer's technical reference, approved data/specification and/or CAAP approved data, as revised.
